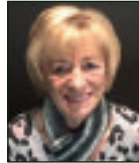
Chris Ray is an experienced hotel finance manager, with several years’ experience working with large hotel groups.

Sarah Spalding has worked for Hilton Worldwide for more than 30 years. Her most recent role was cluster director of finance for South West

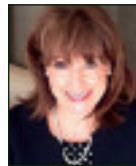


England, overseeing seven four-star hotels.



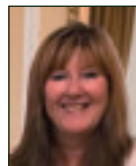
